Board President Anderson stated the following announcement:

Representatives of the news media are specifically directed not to report on or otherwise disclose any of the deliberations or anything said about subjects discussed during the executive session, except to state the general subject of the session as previously announced by the District.

All attendees, by their continued presence, affirm that during the executive session, each is in a secure location, no unannounced person is attending with them, no recording is being made, and no concurrent broadcast is occurring.

No decision may be made in executive session. At the end of the executive session, we will return to an open session and will electronically connect any person who attended the open session or who now wants to attend the open session.

Anderson then asked that each member to orally confirm that he/she heard and understood the rules of the remote executive session; members confirmed.

Heimuller moved and Hennessy seconded to approve the application (SEL 805) of the ballot title stating 'Renewal of 9-1-1 Emergency Communications Operating Funds – Option Levy' as presented in preparation for the upcoming Spring election. Anderson clarified that this was previous business that held over as staff was trying to establish the filing date with concern that we may be running out of time to file. As of 30 minutes ago staff attempted to seek clarification from the county elections office and were unsuccessful in getting a definitive answer. Motion carried unanimously.
