## **Old Business:**

Radio System:

#### Meissner Construction:

- Nearing Completion

#### Phase 3 Microwave Upgrades:

 As a part of the completion of the Meissner site project, Day Wireless is the sub-contractor for MNI. Installation of the MNI equipment and antennas will be accomplished by months end.

## NextGen Radio Project:

- Wednesday April 16, The District instructed FE to formally cancel the LMR Project ITB after receiving three no-bid letters. The District recommend the following individual notice to each solicited vendor, that would read:
- Notice is given that the Columbia 9-1-1 Communications District's ITB solicitation is canceled. This notice is in the public's best interest. In part, this notice is in response to your no-bid letter. But this notice is also given because of violations of the bidding instructions by communicating with third parties. (ORS 279C.395)

#### PDCC Resiliency Study & Recommendations:

 The District is happy to report that we are the recipients of 2 Motorola "All-In-One" portable Vesta 9-1-1 work stations via the PDCC Reiliency Study preliminary recommendations. The timing of these recommendations happened to coincide with the availability of some UASI re-programing grant funds that were then used for the purchase. A saving to the District of over \$20,000.00

This new equipment allows us to continue to outfit our 3 dispatch workstations in the extension building. This next FY we will be replacing our operation floor CAD workstations and relocating the surplus machines to the same area as these 9-1-1 positions.

## **New Business:**

The District has embarked on a training and leadership course with the help of a company called SCGI, Stuart Consulting Group, Inc. of Bremerton, WA.

## School of Leadership, Class of 2024 (March - November 2024)

Nine (9) 3.5 – hr. sessions, once per month, designed to create clarity and alignment among all leaders within the agency and to enhance leadership, management, and supervisory skills. The course is designed to include anyone with supervisory, management, or lead responsibilities. It covers at least the following:

- Self-management skills, including how to become resilient
- o How to lead in the unique work environment of an Emergency Communications Center
- How to manage conflict and solve complex problems on the fly
- o The high cost of a negative workplace
- How to create and maintain an intentionally healthy culture
- How to address performance problems
- Challenges of leading different workplace generations
- o The Discipline of Direct Communication

The instructors are a team of Dr. De Hicks, a Neuropsychologist and Donnie Quitugua. Bio's are attached.
